

RELEASE AND INDEMNITY AGREEMENT FOR THE CAPE GIRARDEAU COUNTY GUN CLUB AND THE MISSOURI DEPARTMENT OF CONSERVATION

I, the undersigned, acknowledge and agree, on behalf of myself and for my minor children accompanying me, personally assume all risks in connection with shooting or other activities conducted at the Apple Creek Conservation Area Trap and Skeet Range. I also agree that I, my heirs, distributees, guardians, or legal representatives will not make a claim against, sue, tax the property of, or in any way pursue a claim arising out of my participation in or presence at any Cape Girardeau County Gun Club or Missouri Department of Conservation event for any incident which may befall on me, or by my hand, resulting in personal injury, death, or property damage, resulting from negligence or other acts, whether caused by the negligence of the Cape Girardeau County Gun Club or the Missouri Department of Conservation management personnel or guests on the facility or otherwise. I am aware that shooting and being a spectator while others are attempting to shoot with a gun is a potentially hazardous activity, and I am voluntarily participating in these activities with the knowledge of the danger involved in them and have been given an opportunity to ask questions and have reviewed the program and safety rules of the facility. I also understand that slight variations may occur in the safety precautions taken by the Cape Girardeau County Gun Club and the Missouri Department of Conservation management and I am willing to accept these changes without reservation. I further understand that I have a choice of whether to participate or not to participate in shooting activities, and I further understand that I cannot participate in any shooting activities without signing this Release and Indemnity Agreement. I am fully aware that the privilege to participate in shooting activities will not be offered to me if I do not execute a complete release and discharge of liability for the Cape Girardeau County Gun Club, its employees, members, officers, volunteers or sponsors of any event; and the Missouri Department of Conservation their employees, members, officers, volunteers or sponsors of any event. By signing this agreement I agree to follow all instruction and safety provisions set out by the Cape Girardeau County Gun Club and the Missouri Department of Conservation. I also understand that in the event that the Cape Girardeau County Gun Club or the Missouri Department of Conservation personnel determine that said safety rules or procedures are not being strictly followed, I will immediately be asked to discontinue my activities at the Apple Creek Conservation Area Trap and Skeet Range and I will voluntarily leave the premises. I further agree to indemnify and hold harmless the Cape Girardeau County Gun Club, its employees, officers, members, volunteers and the sponsors of any event and the Missouri Department of Conservation, its employees, officers, members, volunteers and the sponsors of any event harmless for any injury or damage caused in any way by me or to me.
